IN OCTOBER, 2013 THE FOUNDATION HELD STUDIOE, AN ART THERAPY PROGRAM FOR ADULTS WITH EPILEPSY. THE FOUNDATION CONDUCTED A WEEK-LONG SUMMER CAMP FOR KIDS AND HAD 16 CHILDREN FROM THE SERVICE AREA ATTEND, AN ADULT RETREAT WITH 43 ATTENDEES FROM THE SERVICE AREA, AND A DAY OF PROGRAMMING FOR BROTHERS AND SISTERS OF KIDS WITH DISABILITIES, WITH 28 IN ATTENDANCE.
